Non-EU members will have to provide a valid **V.A.T. registration Code** and/or a **Tax Identification Number** (subject to verification). Without the above-mentioned VAT registration number and/or Tax Identification code, Italian VAT will be added to all invoices.

- Deadline to register at **discount rates:** **31 October 2016**
 - Official **closing date** to register at Enolitech 2016: **30 November 2016**
 - Deadline to settle the total amount due for the exhibition space: **19 February 2017**
- Minimum exhibit space: 16 sq.m. (4x4 meters with 1 open side)
