Non-EU members will have to provide a valid **VAT registration Code** and/or a **Tax Identification Number** (subject to verification).

Without the above-mentioned VAT registration number and/or Tax Identification code, Italian VAT will be added to all invoices.

- Deadline to settle the total amount due for the exhibition space: **10th February 2022**

-> Minimum exhibit space: 12 sq.m. (3x4 or 4x3 meters with 1 open side)

The above-mentioned rates include the following services:

- ✓ Registration and inclusion in Vinality Plus;
- ✓ One copy of the Official Exhibitors Catalogue, plus the personalization of the online Vinality Plus page;
- ✓ Insurance cover for civil liability risks for third-parties and insurance for other Exhibitor risks in accordance with the maximum sums and conditions envisaged in the event General Regulations;
- ✓ Free advertising tax inside the stand area lower than 3 meters from ground and according to the limits defined in the event General Regulations;
- ✓ Access to the online Business Portal enabling to take advantage of several services such as: purchase service for personalized invitation cards, free-badge service dedicated to the foreign operators, registration in the matching service with international buyers, inclusion of company News and consequent publication on the event website – Vinality.com;
- ✓ n. 80 electronic invitations for international operators: 4-day entrance ticket valid once a day, as specified in the dedicated service inside the Exhibitors' online Business Portal;
- ✓ Internet wireless connectivity, valid during the event timespan and with no time limit:

- ✓ Electrical connection (n.1 connection) and electricity consumption (3 Kw every 16 sq.m.);

- ✓ Stand cleaning (day before the event, evening cleaning for show days, emptying of wastepaper baskets and dusting of furnishings);
- ✓ Exhibitor Passes (n. 1 for Direct Exhibitor Registration Fee, n. 1 every 8 sq.m of basic exhibition area, n. 1 for each Co-exhibitor registered);
- ✓ Heating-ventilation, general surveillance;
- ✓ General lighting of halls, information, sanitary facilities, first aid.
