Exhibition tariffs above include the following services:

- registration in the Exhibitors' Official Catalogue;
 - insurance cover for civil liability risks for third-parties and insurance for other Exhibitor risks in accordance with the maximum sums and conditions envisaged at Article 13.2 of the General Regulations;
 - advertising tax for stands as per the limits defined in Article 12.3;
 - n° 2 free exhibitor passes and n° 2 free exhibitor passes for every 16 sq.m. booked;
 - n° 2 car parking passes. The parking areas reserved for Exhibitors are available until all places are fully booked and are not supervised. The Organiser declines any and every responsibility for eventual theft or damage that may involve parked vehicles;
 - Internet wireless connectivity: n° 1 account valid for the entire show period;
 - advertising fee for audio-visual and sound promotion;
 - general promotion;
 - heating, ventilation, general surveillance (excluding stands);
 - general lighting of halls, information, sanitary facilities, first aid, supervision by firefighting authority;
 - basic electric package (2Kw for every 16 sq.m. and 1 electrical connection).
- Important note: for technical services (electricity and water), it is compulsory to compile online requests and, for water services, to attach the ground plan indicating the positions of the connections;
- access to the online personal area, allowing exhibitors to take advantage of different services such as: invitation card service, free badge service for foreign trade visitors and publication on the event website;
 - n° 100 online invitation cards for every 16 sq.m. Invitation are valid for one entry per day for the entire show period, as specified in the exhibitors' personal area;
 - daily cleaning of the exhibit area for the duration of the show (only for indoor exhibit area) excluding materials/machinery on show.
