16 MARCH 2018: official registration **deadline** for the Marmomac

- ⇒ Official **closing date** to register for the Marmomac *: **16 March 2018**
⇒ Deadline to settle the amount due for the exhibition space: **6 July 2018**

* the Registration Application and space request is complete only once the 30% advance payment is received by Veronafiere.

- ✓ Minimum exhibit space: **16 sq.m** indoor (4x4 metres with 1 open side); **40 sq.m** outdoor.
- ✓ Minimum space for a stand with 2 open sides (*if available*) inside the Pavilions: **32 sq.m**

The above-mentioned rates include the following services: free registration and insertion in the Official Catalogue (*Company details and a brief description*); one copy of the Official Catalogue; registration and insertion in the List of Exhibitors published on the event site; insurance cover for civil liability risks for third-parties and insurance for other Exhibitor risks in accordance with the maximum sums and conditions envisaged in the General Regulations; free advertising tax for stands as per limits defined in the General Regulations; free WIFI internet connection as indicated in the General Regulations; free Exhibitor Passes for access to the event and parking cards; electrical connections and consumption of electricity as detailed in the event regulations; general cleaning of the stand -excluding materials/machinery on show- from the day before the event and every evening of event days; 300 electronic invitations for your customers; access to the services that will be made available in the Exhibitors Exclusive Area; general surveillance (*stands excluded*) and general promotion of the event.

The above-mentioned rates –*except the rates mentioned above for fully fitted/equipped indoor areas from 16 up to 48 sq.m*– do not include stand fittings (e.g.: partition walls, electric plant, carpet, furniture).
