**Exhibition tariffs above include the following services:**

- insurance cover for civil liability risks for third-parties and insurance for other Exhibitor risks in accordance with the maximum sums and conditions envisaged at Article 13.2 of the General Regulations;
- advertising tax for stands as per the limits defined in Article 12.3;
- n° 1 free exhibitor pass for the Registration free Direct Exhibitor and n° 1 free exhibitor pass for every 4 sq.m up to a maximum of 40 passes;
- n° 1 car parking pass. The parking areas reserved for Exhibitors are available until all places are fully booked and are not supervised. The Organiser declines any and every responsibility for eventual theft or damage that may involve parked vehicles;
- Internet wireless connectivity: n° 1 account valid for the entire show period;
- advertising fee for audio-visual and sound promotion;
- general promotion;
- heating, ventilation, general surveillance (excluding stands);
- general lighting of halls, information, sanitary facilities, first aid, supervision by firefighting authority;
- basic electric package (2Kw for every 16 sq.m. and 1 electrical connection).  
Important note: for technical services (electricity and water), it is compulsory to compile online requests and, for water services, to attach the ground plan indicating the positions of the connections;
- n° 50 online invitation cards;
- daily cleaning of the exhibit area for the duration of the show (only for indoor exhibit area) excluding materials/machinery on show.
