IMPORTANT DEADLINES

- ✓ Deadline to settle the amount due for exhibition space: **20 September 2022**

The Registration Application is valid only once the advance payment is received by Veronafiore and the date of the payment will be used to define eventual application of promotional/special rates, as indicated above.

IMPORTANT: Italian VAT (22%) can be excluded from the invoices only if you provide a valid intercommunity VAT registration number on submission of the application form. Non-EU members will have to provide a valid V.A.T. registration Code and/or a Tax Identification Number (subject to verification). Without the above-mentioned VAT registration number and/or Tax Identification code, Italian VAT will be added to all invoices.

The above-mentioned rates include the following services:

- ✓ registration and insertion in the Official Catalogue;
- ✓ registration and insertion in the List of Exhibitors published on the event site;
- ✓ insurance cover for civil liability risks for third-parties and insurance for other Exhibitor risks in accordance with the maximum sums and conditions envisaged in the General Regulations;
- ✓ free advertising tax for stands as per the limits defined in the General Regulations;
- ✓ Free Exhibitor Passes for access to the event:
 - n° 1 pass every 8 sq.m.;
 - n° 2 pass for «Direct Exhibitor» registration fee;
