  - ✓ Insurance cover for civil liability risks for third-parties and insurance for other Exhibitor risks in accordance with the maximum sums and conditions envisaged in the General Regulations (more information on the **Exhibitor's service Manual**);
  - ✓ Free advertising tax for stand as the limits defined in the General Regulations;
  - ✓ Access to the Confidential Area includes services such as: purchase service for personalized invitation cards; matching service with GDO national buyers; inclusion of Company News and consequent publication in the "Company News" area of the event site: **SOLAGRIFOOD.COM**;
  - ✓ Electrical connection (n.1 connection) and electricity consumption (2 Kw every 12/16 sq.mt.);
  - ✓ Stand cleaning (day before the event, evening cleaning for show days with vacuum cleaner for carpeting, emptying of wastepaper baskets, ashtrays and dusting of furnishings);

- ✓ N° 1 account internet wireless connectivity for each Exhibitor and each Co-Exhibitor

**IMPORTANT:** the European Commission has adopted a new Directive aiming at simplifying the VAT rules for services in EU. Veronafiere can exclude Italian VAT (22 %) from the invoice if you provide a valid intercommunity VAT registration number on submission of the application form.

Non-EU members will have to provide a valid **V.A.T. registration Code** and/or a **Tax Identification Number** (subject to verification).

Without the above-mentioned VAT registration number and/or Tax Identification code, Italian VAT will be added to all invoices.

- Official **closing date** to register: **31 January 2019**
- Deadline to settle the total amount due for the exhibition space: **22<sup>nd</sup> February 2019**
